

Overall Performance	Weighted average of 22 criteria such as a law firm's ethics, administration, capacity, project management, lawyers' competence, creativity and pricing. Scale 1-5. Each criterion is weighted by its importance. Law firms of which less than 8 interviewees have an opinion are excluded. Only firms included in all categories constitute the base for the ranks in the All Interviewee category. The order of firms with an equal overall performance score is decided by the market penetration, Tier 1 & 2, or knowledge, Lawyers & CEO/CFO. In case the last rank is tied only the firm with the highest market penetration/knowledge will be included in the top 5. Asterisk * marks tied ranks.						
Rank Market Penetration	Market penetration expresses the percentage of organisations mentioning a certain law firm as a supplier of commercial law services in Sweden the past 12 months.


