

Method

Telephone interviews by TNS SIFO Prospera's interviewers

Time Period

March 11th until May 21th, 2010

Overall Performance Weighted average of 21criteria such as a law firm's ethics, administration, capacity, project management, lawyers' competence, creativity and pricing. The scale ranges from 1 to 5, 5 representing the highest score. Each criterion is weighted by its importance. In all 11 local law firms are covered by the survey. However law firms which less than 7-8 interviewees have an opinion of are excluded. Asterisk * marks tied ranks. Only firms included in Tier 1 constitute the base for the ranks in the All Interviewee category. The order of firms with an equal overall performance score is decided by the market penetration, Tier 1, or knowledge, Lawyers & CEO/CFO. In case the last rank is tied only the firm with the highest market penetration/knowledge will be included in the top 5.


